Design requirements that would support the use of the building product:

The FAR Underfloor heating manifold kit is suitable for use in proprietary heating systems. These include embedded heating pipes in concrete slabs and circulation pipes for radiator type heating systems. These systems are to a specific design by the heating system proprietor.

The FAR Underfloor heating manifold kit must not be connected to auxiliary heaters such as solar collection panels or wet backs without the installation of temperature protection devices in the system. Without protection temperatures may exceed the operating limits. The FAR Underfloor heating manifold kit must not be installed within 1 metre of an inlet or outlet of these types of auxiliary heaters.

Building design must consider the requirement of building code clause H1 for heated floor systems.

Installation requirements:

Please refer to the Underfloor heating manifold kit <u>installation guide</u> and <u>product specification</u> supporting information provided on the Central Heating NZ website.

As the FAR Underfloor heating manifold kit is not stainless steel it may not be used in environments that would be conducive to corrosion.

Ensure ¾" Eurocone Multitubo Composite or PE-RT pipe connectors are used when connecting the underfloor pipe to the manifold.

When filling the system, ensure the manufacturer's instructions for flushing and filling the underfloor pipe loops and manifold are adhered to using a suitable flushing cart.

The installation of FAR Underfloor heating manifold kit system components must be carried out by a trained and qualified installer, familiar with the FAR Underfloor heating manifold kit installation requirements.

Maintenance requirements:

Access for routine inspection, maintenance and replacement is required as part of building design.

During annual <u>maintenance</u> the service provider should perform a visual inspection for any possible leaks.
